2. Contractors are to furnish earnest money in the form of Bank Draft/DCR in favour of the **Executive Engineer, Electrical Division-I, Housing Directorate** and the same should be attached with the tender, in absence of which the tender will be declared as informal.

3. Intending tenderer must apply in writing together with documentary evidence in support at their experience and competency to execute such type of work. Tenderer should produce a successful credential : i) A similar nature of work of the minimum value of 40% of the estimated amount put to tender during the last 5 (five) years prior to the date of issue of this Notice. ii) At least two similar nature of works, each of minimum value of 30% percent of the amount put to tender during the last 5 (five) years prior to the date of issue of this Notice. iii) One (01) single running work of similar nature which has been completed to the extent of 80% or more & value of which is not less than the desired value of the above. In this every case only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer or equivalent competent authority. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiate against the executing agency.Valid GST/IT/P.T/PAN CARD/ Trade License Certificate, SCC(1,2,4,7(a)&11) must be produced for obtaining permission from the undersigned.

4. The tenderer must have valid Electrical Contractor License as per C.E.A(measures relating to safety and electric supply) regulation,2010

5.Schedule of work and specification etc can be seen and copies thereof may be had from the office of the undersigned during office hours on week days.

6.Tender which should always to be placed in sealed covers with the name of the work written on the envelopes will be received by the above Office up to 2.00 P.M. on 30/11/2023 and will be opened shortly on the same day in presence of such intending Contractors or their agents as may be choose to attend.

7.Rates should be quoted in figures as well as in words in terms of percentage above / below or at par of the total amount put to tender and shall be applicable to each individual item. No ST will be paid extra. No tender with price variation clause will be entertained.
