Representative from Shapoorji Pallonji and Company Private Limited narrated the points as raised thorough e-mail and discussion was made in details.


Representative from MC Nally Bharat Engg Co. Limited narrated their quarries and discussion was held point wise.

Representative from Simplex Infrastructures Limited narrated their quarries and discussion was held accordingly.






Project : Soil Investigation work for proposed Housing Project at Plot 'A', Bijo Nagar, Jamuria, District- Burdwan.
