The Engineers Co-opt. Societies as well as Regd. Labour Co-operative Societies will have to produce A.R.C.S. Bye-Laws current audit report, credentials for last 5 years alongwith payment certificate and work completion certificate showing the tender nos., Year, date of completion etc. by the appropriate authority, list of office bearers holding of plumbing licence by at least one number of the said societies in case of participation in tender relating S&P works vide F.D.G.O-1341F dt. 21.02.2001 & H.D.S-III W.B.No. 1350(7)-A/4M-37/2002 dt. 15.11.2002 & other relevant papers in original attested Xerox copy along with their application for seeking permission to participate in tender.

Attested copies of documents produce during application will be retained by the Executive Engineer, Housing Construction Division No. IV. The Executive Engineer, Housing Construction Division No. IV preserve all the rights for cancellation of any application without showing any reason after scrutiny of the application.

As per P.W.D., (Accounts Branch No. 378(9)-A/PW/O/10C-17/05 dtd. 31.05.05 the Co-operative Societies will not get the privilege of being within the reserved category as envisaged under clause (1) of the P. W. Deptt. Order no. 4810A dtd. 4.9.1974).

The successful tenderers will have to produce valid upto date Sales, Tax clearance certificate in original on receipt of work-order from this end within the specified time positively if not produced earlier. Tender documents with 2911 (i)/(ii) only will be sold at the time of formal execution following the then order of Finance Deptt. Govt Of West Bengal.

Eligible tenderers should arrange to procure tender paper well in advance to avoid difficulties due to downloading of tender papers. In terms of F.D.S.G.O.No. 5895-F dt. 11.09.06 & C.E/HD's memo no. 1635(4)/HD dt. 10.10.2006 cess upto 1% from the contractor's bill shall be deducted for W.B. Building and other construction workers, welfare Board.

**N.B.** – In case of any unavoidable circumstances occurred on the aforesaid dates the next working day will be treated as schedule / prescribed for the same purpose.
