No arbitration will be allowed for the work as per provision for making arbitration vide clauses 25 in W.B.F No. 2911(ii)

Recovery of 1 % cess on total cost will be charged under the building and other construction workers welfare Cess Act 1996.

The schedule and other allied papers may be seen and copies thereof may be obtained from the office of the undersigned after getting written permission from him. Earnest Money by Bank Draft or pay Order of any nationalized Bank should be drawn in favour of Executive Engineer, Electrical Division No II Housing Directorate should be attached with the Tender by all the participating tenderers. Tenderers must produce documentary evidence to prove their competency to execute such type of Govt. work valid income Tax and Sales Tax Clearance Certificate must be produced by the Electrical /Contractors, possessing Contractor' Licence having Electrical Supervisor with Certificate of competency covering 1,2,3,4,5,6,7 and 11 of Rule 19 (R) of I.T.Rules for permission from the undersigned to procure tender forms. Rates should be inclusive of VAT which will not be paid extra. No tender with variable price clause will be accepted. Acceptance of lowest or any tender is not obligatory.

Valid Income Tax & Sales Tax clearance certificate must be produced before obtaining permission for submitting tender. Tenderers must produce documentary evidence to prove their competency to execute such type of Government works. Rate quoted should be valid for a period not less than three months from the date of opening of Tender. No tender with variable prior clause shall be considered for acceptance.
