- 1. The tender will be publicly opened in the manner stated in item of printed N.I.T. From.
- 2. The tender documents & others particulars may be seen at the aforesaid office on all working days during Office hours.
- 3. If any unforeseen circumstances, the office remain closed or non functioning on the dates mentioned in Sl. No. J, K, L, M of this N.I.T. the said dates will automatically have changed without any further notice to the next working day immediately following such incident the time remaining the same.
- 4. Applicant must submit self-attested photo copy of Current P.T. Challan, G.S.T. Registration Certificate, up to Date G.S.T. Return, PAN Card of Income Tax, Current Income Tax Return, and Valid Trade License along with their application for issue of Tender documents. Applications are also required to produce Original Copy of above documents for verification at the time of submission of their application.
- 5. Tender will be accepted subject to the administrative approval & availability of fund
- 6. If there be any type of mistake is rate, provided in the specific price Schedule of rates due to in advertence or any confusion arises will be short out with the prevailing circle schedule of rates sanctioned.
- 7. In case of power of Attorney holder of partnership firm, Deed should be duly registered with appropriate authority otherwise it will not be entertained.
- 8. The contractors should quote in his own hand writing in figures as well as in words in the rate in percentage above/below /AT PAR on the rate & amount of the price schedule of items with probable quantities. The contractors must sign either in English, Bengali or Hindi.
- 9. Conditional tender will not accept in any case.
- 10. The payment will be made by the Executive Engineer, Bankura Division, Housing Directorate, which will depend on availability of fund & no claim what so ever will be entertained for delay of payment, if any intending tenderers may consider these criteria while applying for permission & while quoting their rates.
- 11. Bonafide outsiders having 40% credential in similar nature of Govt. / Semi Govt. work within the last 5(five) years from the date of issues of NIT will be taken into the consideration for according permission to the bidder.
- As per G.O. No. 4608-F(Y) dated 18.07.2018 of Finance Department, Govt. of West Bengal, Additional Performance Security @ 10% of the tendered amount shall be obtained from the successful bidder if the accepted bid value is 80% or less of the Estimated amount put to tender. The Additional Performance Security shall be submitted in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order.
- 13. An intending tendered shall clearly understand that in the event of acceptance of his/her tender, he/she shall have to comply with the following Labour Laws applicable to establishments engaged in building and other Construction work. - 14. Constructions worker's welfare cost @ 1% of the gross bill amount will be deducted from bill of the agencies in pursuance of Memo No. 599A/4M-28/06 Dt. 27.09.2006 of the Engineer-in-chief P.W.D. & P.W. (Roads) Department.
- 15. Contractor should have to ensure the engagement of job card holders as unskilled workers registered under MGNREGA for execution of awarded works.
