As per Clause (2) of bye-laws 5 of the West Bengal Apartment Ownership Bye-Laws, 1974 the number of Managers of the Board shall be equal to one - third of the number of apartment owners of the property concerned but in no case it shall be less than three(3) or more than twenty four(24) .
