
Terms and Condition of Auction Sales

- 1) It shall be deemed that all bidders have through read and under stood the terms and conditions of sale before bidding it will also deemed that all the bidder have inspected the properties prior to auction and have satisfied themselves with the full particulars of the same. No objection or claim of any nature whatever shall be entertained at the conclusion of the auction. The sealed bid should reach the office as mentioned in the enclosed list on the date and time as mentioned in the furnished list. The materials will be auctioned on "As is where basis".

the acceptance of the highest bid shall not be treated as the final acceptance of the bid and the highest bidder shall have no claim on the materials to be auctioned until and unless the bid money is deposited by the highest bidder.

From the date of lifting order by the E.E. for removing the materials sold to the purchaser to the last day for the removal of the materials by the purchaser, the materials at the site will remain at the entire risk, responsibility and expenses of the purchaser.

- 4) The successful bidder shall have to deposit the full bid money within 3(three) days of the issue of letter of Acceptance failing which earnest money shall stand forfeited to the Government and the bidder shall be debarred from participating in any auction under the Government work for a minimum period of one year.
- 5) The sealed bids received will be opened in presence of participating bidders who may like to remain present at the time of opening bid on above mentioned date.
- 6) **Each intending bidders shall have to deposit the earnest money @ 2% on quoted amount through Bank draft/ pay order in favor of the Executive Engineer, Kolkata North-II Division, Housing Directorate, drawn on any nationalized bank along with his offer (written in the annexure sheet) in the sealed cover.**
- 7) Earnest money of the successful bidder shall be converted in to security deposit. The Earnest money of all bidders other than highest second bidder will be refunded after opening of bids.
- 8) If the highest bid in the opening of the undersigned does not appear to be satisfactory the undersigned reserves the right of holding fresh bid and so on.
- 9) Each bidder or his authorized representative shall have to remain present at the time of opening the bid so that table bid may be held if required immediately after opening the bid.
- 10) On receipt of the full bid money after acceptance the undersigned will issue order for lifting the materials to the highest bidder. The auctioned materials must be removed from site within the stipulated time. In case of any damage to the public property during lifting and transportation of the auctioned materials towards rectification/renewal of the property shall be recovered from the bidder on the basis of the estimate prepared by this office.
- 11) After completion of the lifting work as per specification laid hereunder and to the full satisfaction of the undersigned the security money as deposited in the form of earnest money by the successful bidder will be refunded without any interest.
- 12) If the materials are not removed wholly from the site within the stipulated time, the material will become the property of the Government and the entire bid money deposited by the purchaser including the Security deposit shall be forfeited to the Government.
- 13) Each participant including the highest bidder or his authorized representative during the opening of the sealed bid will sign an attendance sheet and Notice inviting Bid before entering the same in which sealed bid will be opened. Persons not participating in the Auction sale will not be allowed to remain present during the time of opening of sealed bid.
- 14) Failure on the part of any bidder to observe and abide by any or all the above noted terms and conditions will disqualify himself to become eligible bidder and his security deposit or part there of as necessary may stand forfeited to the Government.
- 15) The undersigned reserves the right to reject any or all the bids without assigning any reason.
- 16) The intending bidder is requested to quote the rate in his own handwriting in figure as well in words clearly.


