

All intending tenderers personally or by person holding "power of attorney" should submit Trade License, Firm Registration Certificate, Partnership Deed, Professional Tax Clearance Certificate along with Current Challan., Pan Card & I.T Return [Last 03 (three) year], GST Registration Certificate along with Current Challan, Credential, Valid Current Audit Report, NOC from A.R.C.S., Registration Certificate / Certificate for validity of Registration, Minutes of last A.G.M., Bye law, for Reserved Unemployed Engineers Co-operative Society ltd. 
