It may be stated that as per bye-law 3 of the West Bengal Apartment Ownership Bye-Laws, 1974 each apartment owner is a member of this Association.

It is further stated that within 15 (fifteen) days of formation of this Association under Clause (3) of bye-law 5 you shall serve notice upon each member of this Association fixing therein the date (not before fifteen days from the issue of such notice) on which and the time and place at which a Special General Meeting shall be held for election of the Managers of the Board of this Association by secret ballot in such manner as may be decided at the said meeting.

As per Clause (2) of bye-law 5 the number of Managers of the Board shall be equal to one-third of the number of apartment owners of the property concerned but in no case it shall be less than three (3) or more than twenty four (24).

Within a month the Association shall create an e-mail id which will be used for all future communication between the Association and the Competent Authority.
