It is further stated that within 15 days of formation of this Association you shall serve notice upon each member of this Association fixing therein the date (not before fifteen days from the issue of such notice) on which and the time and place at which a Special General Meeting shall be held for election of the Managers of the Board of this Association by secret ballot in such manner as may be decided at the said meeting under Clause (3) of bye-laws 5 of the West Bengal Apartment Ownership Bye-Laws, 1974.

As per Clause (2) of bye-laws 5 of the West Bengal Apartment Ownership Bye-Laws, 1974 the number of Managers of the Board shall be equal to one - third of the number of apartment owners of the property concerned but in no case it shall be less than three(3) or more than twenty four(24) .
